ARTICLE 6: Authorize the District to appropriate and borrow \$3,000,000 in addition to the \$6,000,000 previously appropriated by vote of the District under Article 6 of the warrant for June 15,2020 District meeting from the Massachusetts Clean Water Trust for the purpose of financing the Oakdale Well Water Treatment Facility project and appurtenances as printed in the warrant

Motion:

Stanley Szczurko made a motion to accept Article 6 as read

and explained.

James LaMountain seconded.

Discussion ensued.

Stanley Szczurko explained than the treatment plant is for removing Manganese from the well water to get it to an acceptable level, which will get the District into regulatory compliance.

Michael Ohl, CEI, further explained the current bidding environment as the reason the District received only one general contractor bid and the higher price. There is a lot of work out there and material prices have spiked due to the pandemic. Not accepting this bid will delay the project and cause the District to be in noncompliance with the ACO and subject the District to fines. Additionally, the date to be eligible for principal forgiveness would be missed, which could be a substantial percentage, the District received 13% on the North Main Street Water Main project that is just completing.

Delaying the project does not guarantee more bidders, better prices, or eligibility for principal forgiveness but causes the fines to accumulate.

GREETINGS:

In the name of the Commonwealth of Massachusetts you are directed to notify the inhabitants of the West Boylston Water District of West Boylston, qualified to vote in elections and District affairs, to meet at the West Boylston Water District, 183 Worcester Street, West Boylston, in such District, on Monday the seventh (7th) day of June in the year of 2021 at 6:00 o'clock in the evening, then and there to act on the following articles:

ARTICLE 1: To elect the following District Officers:

- (A) Moderator for one year
- (B) District clerk for one year
- ARTICLE 2: To hear the report of the officers of the District and to act thereon.
- ARTICLE 3: To see if the District will vote to transfer from any unexpended balances from the Fiscal Year 2021 appropriations or other available funds to Fiscal Year 2022 appropriation accounts or take any action in relation thereto.
- ARTICLE 4: To see if the District will vote to raise and appropriate a sum of money for the District's maintenance and operating expenses budget for Fiscal Year 2022, beginning July 1, 2021 and ending June 30, 2022, or take any action relative thereto.

ARTICLE 5: To see if the District will vote to authorize the District Treasurer, with approval of the Board of Water Commissioners, to borrow money from time to time in anticipation of the revenue of Fiscal Year 2022, beginning July 1, 2021 and ending June 30, 2022, in accordance with General Laws Chapter 44, Section 4, as amended, and to issue a note or notes as may be given for a period of less than one year in accordance with General Laws Chapter 44, Section 17as amended, or any other authority available to the District, and to authorize the District Treasurer to enter into a compensating balance agreement or agreements for Fiscal Year 2022 pursuant to General Laws Chapter 44, Section 53F, or take any action relative thereto.

ARTICLE 6: To see if the District will vote, that a sum of money be appropriated, in addition to the \$6,000,000 previously appropriated by vote of the District under Article 6 of the warrant for the June 15, 2020 District meeting, for the purpose of financing the construction of the Manganese Removal Treatment Facility at the Oakdale Well; including all appurtenances and all costs incidental or related thereto; that to meet this appropriation the Treasurer with the approval of the Board of Water Commissioners is authorized to under Chapter 44 of the General Laws or other applicable authority; that such bonds or notes shall be general obligations of the District unless the Treasurer with the approval of the Board of Water Commissioners determines that they should be issued as limited obligations and may be secured by local system revenues as defined in Section 1 of Chapter 29C; that the Treasurer with the approval of the Board of Water Commissioners is authorized to borrow all or a portion of such amount from the Massachusetts Clean Water Trust established pursuant to Chapter 29C; and in connection therewith to enter into a financing agreement and/or security agreement with the Trust and otherwise to contract with the Trust and the Department of Environmental Protection with respect to such loan and for any federal or state aid available for the project or for the financing thereof; that the Chairman of the Board of Water Commissioners are authorized to enter into a project regulatory agreement with the Department of Environmental Protection, to expend all funds available for the project and to take any other action necessary or convenient to carry out the project, or take any action relative thereto.

And you are to serve this Warrant by posting an attested copy thereof at the Water District Office, Post Office, West Boylston Town Offices, Beaman Memorial Library, Pruneau's Barber Shop and in place of the meeting, seven days at least before time of holding said meeting.

Hereof, fail not, and make due of the Warrant with your doings thereon to the Board of Water Commissioners at the time and place of the meeting as aforesaid.
